

Once you renew your license you will notice that the "current hours avail" will reduce by for or to zero. If for any reason you have taken CE hours and do not see them on the CE History tab, please contact the Board at staff@hacr.alabama.gov.

Also, be advised that it is your responsibility to get four hours of CE prior to the November 1, 2023 deadline. Any CE received after the deadline is not guaranteed to post to your CE History profile before December 31, 2023, which could potentially cause a late renewal. The Board will not waive any late fees for any reason.
