### **NOTICE TO ALL HVAC & REFRIGERATION LICENSEES:**

Starting November 1, 2025, the Board will begin enforcing the CE deficiency plan. Under this new plan, a \$25 deficiency fee will be implemented for contractors who need an extension for their CE submission. This extension will be granted on a case-by-case basis, for a fee, allowing contractors additional time to submit their required hours through December 31st.

The Board strongly encourages all contractors to review the changes to the continuing education (CE) hours deficiency rule. As outlined in Section 440-X-4-.03, the Board has the authority to implement a plan for CE hours taken after the annual November 1st deadline. The new rule permits the Board to charge a \$25.00 fee to contractors who are deficient in hours as of November 1st. The rule became effective on July 14, 2025.
